2. Kindly note that :-

(1) Candidate should get a print out of this call letter to produce the same at the time of Document Verification. Hard copy of call letter will NOT be sent by Commission through post.

(2) Candidate should also bring the following documents **in Original and the Xerox copies thereof, duly self attested**, for verification as well as for record in his/her Dossier:-

- (i) Mark Sheet(s) and Board certificate (s) of Matriculation or High School/equivalent certificate **issued by the State/Central Education Board** showing his/her Date of Birth (In Christian era). Certificate issued by **Principal/Headmaster of School/Institution will not be accepted.**
- (ii) Mark Sheet and Certificates of Intermediate/Higher Secondary/10+2/Senior Secondary in original from a recognised Board or University (Educational Qualification should have been acquired on or before 01.08.2017).
- (iii) Two passport size color photographs and Photo bearing Identity Card (Driving License/PAN Card/Voter ID Card/Aadhar Card/Employer ID Card).
- (iv) The Category Certificate issued by the Competent Authority should be in the format as prescribed in the Notice of Examination in support of his/her claim, viz OBC/SC/ST/PH.

- (v) Discharge Certificate in support of his/her claim being an Ex-serviceman Category (if applicable).
 - (vi) In case candidate is already in Government service/Department, a “No Objection Certificate” from his/her present employer should be produced, failing which he/she will not be permitted to appear for Document Verification.
 - (vii) Departmental candidates who are claiming age relaxation should produce necessary certificate towards having rendered not less than 03 years regular and continuous service as on closing date for receipt of online application.
3. If you do not produce any of the above mentioned Documents (i) to (iii) **and** the requisite certificate if applicable to you from amongst (iv) to (vii), in original_ (along with self attested copy), your **will not be admitted** for the Document Verification under any circumstances and no further opportunity will be given.
4. **No travelling or other expenses** will be paid by the Commission for attending Document Verification.
5. **Any change in your present postal address** should be communicated to this office at once showing your Roll Nos., Name of the Examination and the Post applied for and the changed address.

(6) Your candidature is **Provisional**. You must, therefore, ensure that you fulfill all the conditions of eligibility including the essential qualifications as laid down in the Advertisement/Notice. If at any stage, it is found that you do not fulfill any of the conditions of eligibility, **your candidature will be cancelled and no appeal against such cancellation will be entertained**. The fact that you have been called for Document Verification, does not confer any right to be treated as eligible or qualified in all respects for the post . To avoid any disappointment at a later stage, you are advised to recheck whether you meet all the eligibility criteria as laid down in the Notice of Examination as on crucial date.
